WHAT

Opinion Study of East Tennesseans' Financial Concerns

In the current environment of economic concern, LeConte Wealth Management, LLC, independently commissioned a study – fielded from Feb. 16-25, 2009 – to tap into what East Tennessee residents are thinking about their financial outlook.

(Methodology: Random digit dial sample telephone survey with 602 completed interviews; counties included in the study: Anderson, Blount, Knox, Loudon, Monroe, Sevier. Overall margin of error (ME) is +/- 4% at the 95 percent Confidence Interval (CI). Survey data weighted to bring age and geographic concentrations for the counties into line with known census data for the geography.)

With data analysis just complete, LeConte Wealth Management principals Hoy Grimm and Kevin Painter are available to discuss the study's findings, as well as to add context via their firm's 30 years of financial services experience.

- What confidence level do East Tennesseans have about the economy nationally and in Tennessee?
